Terms and Conditions of Service:

This matchmaking service (The “Service”) is a way for adults to meet each other for the purpose of marriage or a long term relationship. The service is provided by Global Match, whose principal office is located at 15928

Ventura Blvd., Encino CA 91436.

This legal agreement (“Agreement”) is made between _____ and Global Match. This

agreement applies to all users of any Global Match services; Please read this agreement carefully before

registering for the service. By registering for the service you become a Global Match member (a “Member”),

you agree to be a member, and you agree to be bound by the terms and conditions of this agreement for as long

as you continue to be a member. You may not authorize others to use your membership and you may not assign

or otherwise transfer your account to any other person or entity.

Registration and Subscription:

Global Match agrees to provide to its members details regarding matching partners for marriage or long term

relationships for as long as the member is registered and is compliant with Global Match policies. To become a

member you must register to the service. You agree to provide accurate, current and complete information about

yourself as stated on your registration form (“Registration information”). You are well aware that if your

registration information is untrue, not current or incomplete in any aspect, we may terminate thus agreement

and your use of the service ends, and in such event, you shall not be entitled to a refund of any unused

subscription fees.

By your registration you agree to allow us to verify the information provided by any legal means available to us.

Terms and Terminations:

This agreement will remain in full force and effect while you use the service and membership.

You may terminate your membership at any time by sending us written or emailed notice of termination. In the

event that (“A”) you terminate your membership or subscription or (“B”), we determine in our sole discretion,

that you have violated this agreement or our posted privacy statement, you shall not be entitled to, nor shall we

be liable to you for, any refund of any unused portion of any subscription payment we have

received from you,

Even after membership is terminated, this agreement will remain in effect.

Your use of the Service:

As a member, you agree that:

(1) You will use the service in as manner consistent with any and applicable laws and regulations. We reserve the right, but have no obligation, to monitor and/or mediate disputes between you and other members.

(2) You are solely responsible for the content information you provide to other members.

(3) By becoming a member, you agree to report us about the status of relations between you and the

member which we introduced to you. This information is crucial for both you and Global Match in order

to maintain good, if not perfect, customer satisfaction.

(4) When speaking with other members on the telephone or communicating with them by any other means,

you agree to conduct your communication in a polite manner and not to offense or harass in any way.

immediately terminate your membership and you shall not be entitled to the refund of any subscription

payment we have received from you.

(5) Under no circumstances, may you disclose personally identifiable information about another member to

any third party without the member's consent. In such event, Global Match reserve the right to terminate

your membership immediately, and you shall not be entitled to refund of any subscription payments we

have received from you.

Release:

If you have a dispute with one or more of our members, you release us (and officers, directors, agents,

subsidiaries joint ventures and employees) from any claims, demands and damages (actual and consequential) of any kind and/or nature, known and unknown, arising out of or in any way connected with

such dispute.

Dispute Resolution:

This agreement in governed by the laws of the state of California without regard to its conflict of law

provisions. You agree to personal jurisdiction by and exclusive venue in the state and federal courts of the

state of California, City of Los Angeles with regard to any and all claims by you arising out of

or related to
the services. This agreement shall not be governed by the United Nation Convention on
contracts for the
international sale or goods, the application of which is hereby expressly excluded.

Payment Schedule:

Under this payment schedule, you make an initial down payment of \$ 2,800 upon signing of
the membership
agreement and \$ 2,800 at the time of a marriage or after dating the same person for one year.
